1.0 Introduction

- The NV20:2020 is to be implemented through 3 separate
 - Medium term plans
 - The first of which is 2010-2013
 - Tenure of 1st NIP ended in December 2013
- An all inclusive approach adopted for the review of the 1st NIP (2010-2013)
 - Consistent with global best practice
 - Plan is reviewed periodically to pave way for corrective actions
- The report on the review provides an update on the progress made in implementation of the plan
 - Identified challenges that limit performance and also explored the outlook and prospect for the country
- Other key objectives of the plan review exercise were:
 - To assess the performance of the policies, projects and programmes of the 1st NIP
 - Appraise the achievements against the Plan targets
 - Identify inherent gaps in the implementation of the Plan
 - Suggest strategies for addressing the challenges
 - Establish the framework for the development of 2nd NIP



2.0 Where we are Today

- The Review was completed in June 2013
- The draft report on the Review of 1st NIP was extensively discussed at the FEC meetings of 3rd July 2013, 28th May 2014 and 18th June 2014
 - Comments and suggestions received from the Council members
- A retreat/meeting is being planned for all Cabinet Ministers under the chairmanship of the Vice President of the Federal Republic of Nigeria
 - HMNPC is taking the lead
 - Retreat to discuss the updated draft before subsequent presentation to FEC for final approval



3.0 Key Lessons Learnt From the Review

- Slow response to invitation by stakeholders, including Federal MDAs, States and FCT to provide
 - Information for the review of their programmes
 - Following the intervention of the President-in-Council, the response rate improved with all Federal MDAs and 28 States and FCT submitting reports;
- Quality of data was below expectation
 - There is a need to further enhance the quality of data to allow for more robust analysis
 - The shortcoming may be attributed to the weak Statistics Bureaux, M&E structures in MDAs and States, systems inadequacies, poor database, personnel, etc
- Inadequate national data disaggregation at the States and Local Government Levels



3.0 Key Lessons Learnt From the Review (Cont'd)

- Inadequate appreciation and orientation of the MDAs and other stakeholders on the relevance and content of the Plan and its link to the Budget
- Lack of functional strategic plans at the States
- Inadequate plan discipline
- Data challenges
- Capacity gaps



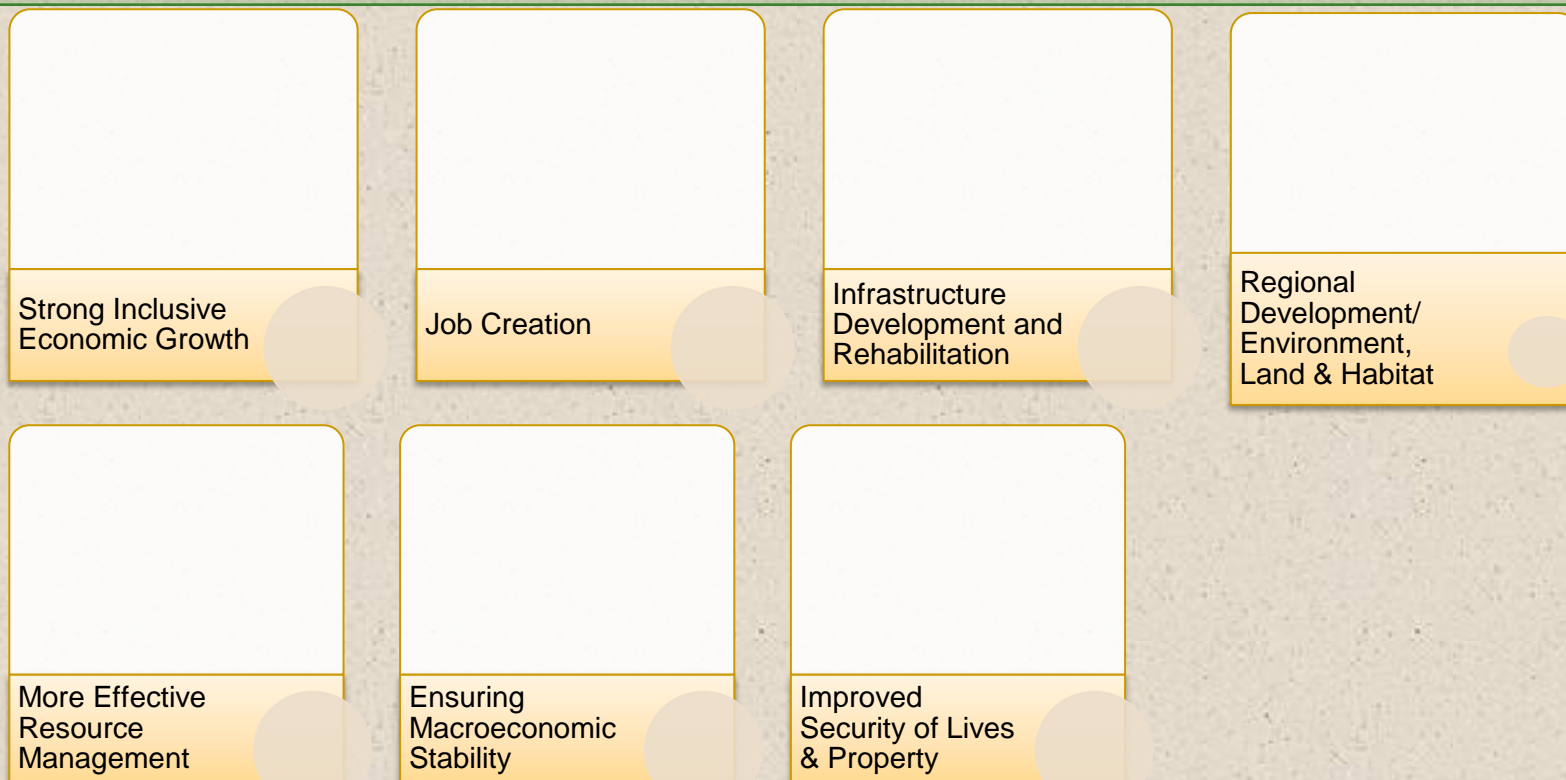
4.0 Proposed Approach for Development of 2nd NIP, 2014-2017

- The process for developing 2nd NIP, 2014-2017 is to be consultative, inclusive and participatory
- A hybrid approach is to be adopted (involving combination of bottom-up and top-down approaches)
 - The 30 year NIIMP is to feed into the plan
- The challenges already identified in the review of the 1st NIP will be addressed
 - In order to have a better articulated Plan
 - The inadequate human and institutional capacities, as well as data challenges at the national and sub-national levels need also to be addressed.
- The NPC is coordinating the 2nd NIP development process
 - Working closely with the Federal Ministry of Finance and other stakeholders at the National and Sub-National levels.
- The focus of the 2nd NIP is to address the gaps identified from the review of the 1st NIP
 - Such as the observed paradox of GDP growth without a corresponding increase in job creation and poverty reduction



4.0 Proposed Approach for Development of 2nd NIP, 2014-2017 (Cont'd)

- The Proposed key thrusts of the 2nd NIP are:



- The proposed timeline for developing the 2nd NIP is Q4 2014 – September 2015

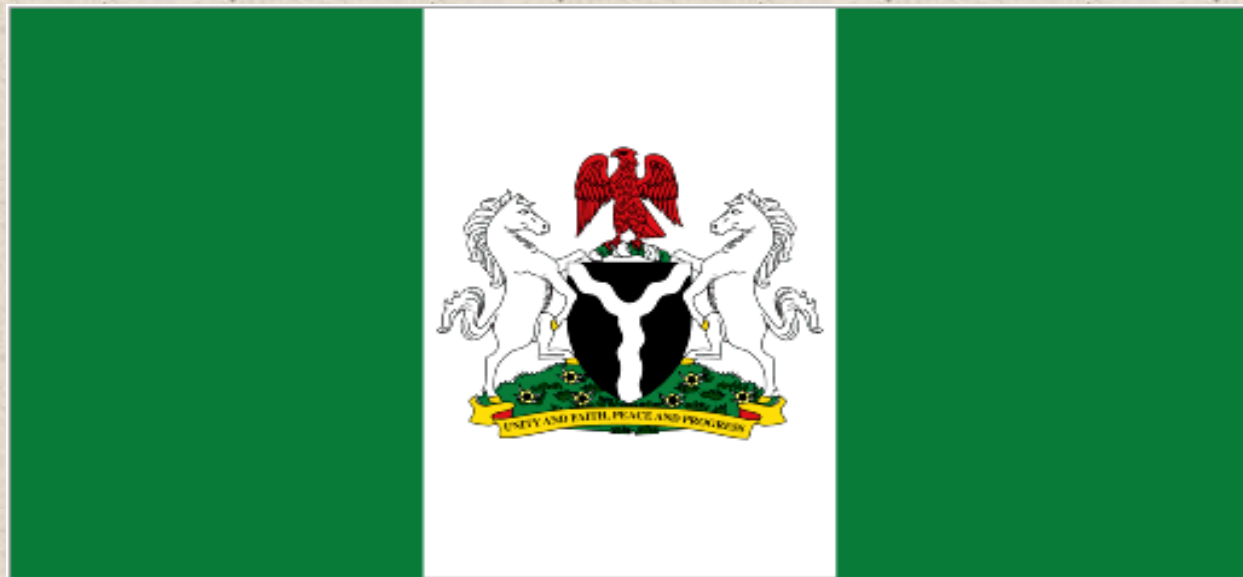


5.0 What Role for JPB?
