1.0 Introduction



- The 1st NIP, 2010 2013 is the first segment of the three medium term plans for the actualization of NV20:2020
- Scope of coverage is 2010 2013
 Guides the annual budgetary preparation process at the Federal level
- Also provides a guide for the development of States' plans and the Transformation Agenda
 Plan is currently being reviewed
 Review consistent with global practices
 Carried out mid-way into implementation or towards the end of tenure
 Consistent with the aspirations of Government's

Transformation Agenda and NV20:2020

2.0 Why Review the 1st NIP

- Allow for indepth analysis of all aspects relating to:
 - The nation's basic development objectives,

Priorities

Sectoral and global dimensions; and

- □Key gaps and challenges
- Highlights the gaps and challenges
 - Efforts made towards addressing the gaps
 - And prospects for the economy
 - Report on the 1st NIP review expected to form critical input into the development of the 2nd NIP



3.0 Progress made so far

- Review process commenced in September, 2012
 - Process was inclusive with representatives of public and private sectors as well as Development partners and NGOs
 - Information/data templates was sent to Federal MDAs and States
 - Template designed to elicit information on the level of implementation of Plan
 - 23 States made submissions on their levels of implementation of projects contained in Volume 3 of the 1st NIP



3.1 Progress made so far

They include:

Abia, Akwa Ibom, Anambra, Bauchi, Cross River, Ebonyi, Edo, Ekiti, Enugu, Gombe, Imo, Kano, Katsina, Kogi, Kwara, Lagos, Nasarawa, Niger, Ogun, Ondo, Osun, Oyo, and Plateau as well as FCT 13 States did not make submissions

They are:

- Adamawa, Borno, Yobe, Taraba, Kebbi, Benue, Kaduna, Jigawa, Rivers, Delta, Sokoto, Zamfara and Bayelsa

3.2 Progress made so far



- Memo on the review was presented by the Hon. Minister of National Planning at the Federal Executive Council on July 3, 2013
- General consensus among FEC members was that the Report was not comprehensive enough As about 40% and 50% of core Federal Ministries and States respectively did not submissions
- The Report was also not consistent with the mid term review of the Transformation Agenda

3.3 Progress made so far



- FEC consequently directed that NPC should rearticulate the report
- □ Taking the relevant inputs from Federal MDAs and States as well as the mid-term report of the TA into account
 - As a result letters were sent to Federal MDAs and States to update information/data on their level of implementation of projects
- Substantial number responded and Inter-ministerial drafting team was constituted to rework the draft report
- Drafting team held several sessions
- Produced a zero draft report

Next step is to invite some of the CWG members that produced the original draft
 Team to validate and finalise the report

4.0 Next Steps

- Timeline for completion of review is December, 2013
- Report to be represented by the Hon. Minister to FEC
- Seek approval for the commencement of the development of 2nd NIP
- 2nd NIP development process expected to commence in December, 2013
- ■Report of the review to form critical input for production of 2nd NIP
- 2nd NIP to guide annual budgetary process for 2015-2017
