1.0 Introduction

- The 1st NIP is one of the three (3) medium term plans for the implementation of NV20:2020
- It was developed and became operational in 2010
 - Approved by FEC on August 25, 2010
- Seeks to engender accelerated pro-poor growth
- Scope of coverage is 2010 2013
- Projected total investment for the plan N32 trillion
 - Out of which:

2.0 The Status of 1st NIP

- The tenure of the 1st NIP has formally ended
- Prior to this a review was done
 - With representatives of Federal, States and Private Sector as part of the review process
- The plan was reviewed after 3 years of implementation to pave the way for corrective action
 - Consistent with global best practice
- The report on the review provides an update on the progress made in implementation against set milestones and targets in the plan
 - Identified key success factors and challenges

2.0 Review of the 1st NIP (Cont'd)

- And to pave way for the development of the 2nd NIP, 2014-2017
 - Establish the framework for the development of the 2nd NIP
- Very comprehensive, covering all sectors of the economy and states' activities, as well as the private sector
 - Takes into account developments in the Global economy
- The report on the review is to be presented to FEC by the Hon. Minister, NPC in a few days time
 - This is to pave way for the development of the 2nd NIP

3.0 Preparation for the 2nd NIP

- The 2nd NIP is to span 2014 2017
- Preparatory arrangement have begun
- Expected to draw from lesson of the 1st NIP review
- Participatory and inclusive approach to be adopted
- States are expected to cooperate with NPC in drafting the process

3.0 Preparation for the 2nd NIP (Cont'd)



- The report has now been updated with submissions from a significant number of States (29) and all the Federal Ministries
- Review took account of the successes recorded by MDAs under the implementation of the TA as documented in the Mid-term Report of the TA
- The review report has been ready and would be presented to FEC very soon
- As soon as the report is approved by FEC, the production of the 2nd NIP will commence

4.0 What Role for Key Stakeholders

- States and Federal MDAs should respond promptly to request for information by NPC for development of 2nd NIP and other Medium Term Strategic Plans as well as sub-sequent plan reviews
- States and Federal MDAs should expedite action to come up with their Sector and Strategic plans that will feed into the national strategic plan (2nd NIP)
 - NPC stands ready to assist in this regard
- States and MDAs should build capacity of the Planning, Research and Statistics officers as they are critical to the development and implementation of national and sectoral strategic plans

4.0 What Role for Key Stakeholders Cont'd

- States and Federal MDAs should build capacity of the Planning, Research and Statistics officers as they are critical to the development and implementation of national and sectoral strategic plan
- States and Federal MDAs should ensure that their annual budgets were consistent with the projects and programmes contained in the medium strategic plans/sectoral strategic plans
- Development partners should also support the process of developing the 2nd NIP, as well as align their interventions with Government's national aspirations
 - UNDP was very supportive in the development and review of the 1st NIP
