About SMP

> SMP

- National Statistical Master Plan (NSMP) was fully implemented from 2005 -2009.
- Implementation of the NSMP was funded through the Economic and Governance Project (ERGP)
- NSMP was used to reposition and strengthen the NSO of Nigeria with focus on:
 - ✓Infrastructure and Equipment
 - ✓ Human Resources Management and Development.
 - ✓ Improved Data Production Methodology
 - ✓ Data Management, Dissemination and Access

About NSDS

> NSDS

- a follow-up statistical strategy to the National Statistical Master Plan (NSMP) implemented from 2005 -2009.
- Marrakech declaration for an Action Plan for Statistics (MAPS) by African Heads of Governments in February, 2004.
- The Strategy is to span over a period of five (5) years (2010-2014)

Purpose of NSDS


- Mechanisms for a holistic reform of the NSS which will ensure a sustainable development of statistics in Nigeria.
- Development of an integrated, harmonized, coordinated and coherent NSS
- Reduce to a bearable level disparity in statistical information among data producing agencies.

Outstanding Issues



- At the National level
- ➤ Adoption of MDAs Sector Statistics Strategy
- ➤ Common pooling of Statisticians in the Public Service
- Adoption of Code of Practice that sets out professional standards in MDAs
- >Full operationalization of e-Template by MDAs
- ➤ Establishment of Nigerian Statistical Trust Fund (NSTF)



■ Outstanding Issues....



At the State level

- > 13 States still without Statistics Edict
- ➤ 16 States have not yet established State Bureau of Statistics
- ➤ 10 States without State Statistical Master Plan (SSMP) in place
- Statistical Advocacy still an issue at the State level
- Getting the States connected to the National Data Centre domiciled in NBS

□Challenges

The major challenges facing the NSDS are in the area of :

- Poor Executive Commitment
- Poor funding
- Slow Pace in the design of the State Statistical Master Plan (SSMP)
- MDAs Sector Statistics Strategy not yet adopted
- Uncooperative attitudes of some agencies







☐ The Way Forward



- High political will to support statistical development
- Improved Funding through Government and Donors
- Increase in statistical awareness through intensive advocacy
- Strengthened collaboration amongst relevant agencies





□ Conclusion

- Statistical development at the sub-national level of Government is critical in building a virile statistical system in Nigeria
- The development of State Statistical Master Plan (SSMP) is the foundation for the drive towards statistical reform at the Sub-national level
- The existence of a Legal Framework is a necessary panacea for the establishment of a State Bureau of Statistics
- NSDS serves as a means of increased support and funding for statistical development at all levels of Government
- There is need to develop statistics at the MDA level through the design and adoption of Sector Statistics Strategy
